Yard Waste Pick-up

Homeowners; just to correct a couple of issues, I thought I would send out a reminder of what you need to know about yard waste pick-up. Pick-up is weekly on Tuesday. If the scheduled day of the week is a statutory holiday the service pick-up would be skipped for that week and the 2 container allowance would be doubled for the following week's pick-up.

Containers must be out by 7:00 a.m. and placed on the road and not the driveway or lawn. The time of day of the pick-up is not guaranteed but we will always start as early as possible. Pick-up will begin in Phase one moving to Phase2 and beyond. If a container is too heavy or cumbersome for one person to lift and empty, it will be left behind. Conversely we will not stop for containers smaller than 5 gallons. Waste wrapped in a tarp, or small barrel is preferred to plastic bags. Extremely small volumes of less than a gallon or two will not be picked up and should be compounded and left out every 2 weeks or more rather than weekly. We will not return on any visit for a late or lightened container.

If ANYTHING BUT YARD WASTE is placed in the container the unit will be struck from the service list permanently - after the second infraction, however minor.

A PLASTIC PLANT POT IS DEEMED TO BE GARBAGE so do not include them in yard waste.
