The stop signs are expected to be installed later this summer.

### Sonoma / Carrington / Butt Intersection

Responses to questions from Sonoma Pines homeowners were passed on to the design engineer(s) and they have provided the response below:

- 1. Were right turn lanes considered (or 2 lanes entering each leg) At 4-way stop intersections it is preferable to have a single lane on each approach. With multiple lanes on each approach there is the potential for 8 cars to arrive at the same time plus pedestrians. The efficient and safe operation of 4-way stops depends upon drivers being able to assess who arrived first and who has the right-of-way. If traffic volumes are indicating a need for multiple approach lanes, then a roundabout or signal is a more appropriate intersection control type.
- 2. Why only 2 crosswalks Crosswalks were positioned to direct pedestrians to the locations where there is a sidewalk to encourage their use. Given it is a 4-way stop there is no extra delay for pedestrians who cross using the crosswalks compared to crossing on the opposite side of the intersection with no crosswalks. In any case, at intersections pedestrians are legally allowed to cross all approaches regardless of whether a marked crosswalk is provided.
- 3. Any way to stop the commercial traffic (from Canadian Tire and Mall to south) from being allowed to turn towards Carrington intersection Not really. Assuming Carrington is not defined as a

- truck route; trucks are still permitted to travel via the local road network using the most direct route between their origin and the truck route. Carrington/Buttis so close to the trucks' origins/destinations that it would be hard to argue against their use of this intersection. Additionally, truck route restrictions are notoriously challenging to enforce with partnership/cooperation between local police and bylaw officers often required.
- 4. Why the transit stop on Butt From checking BC Transit it would appear that route 25 travels on Butt and uses the stop
- 5. Speed bumps on Carrington? Carrington is classified as a Commercial Collector Typically wouldn't put speed bumps on a Commercial Collector. Additionally Carrington is under the jurisdiction of MoTI and they would need to be involved in any decisions regarding speed bumps. I believe a raised crosswalk for Carrington has previously been suggested, but MoTI didn't support it.
- 6.Flashing lights on median approaches to new intersection Temporary flashing yellow warning lights could be provided as part of the transition to the new 4-way stop to increase driver awareness of the change in control



### Here's your real estate run down for mid-2018 in Sonoma Pines

#### Hello fellow Sonoma Pines residents!

We are halfway through 2018 and that means SUMMER!

This time of year is what living in the Okanagan is all about.

Here's your real estate run down for mid-2018 in Sonoma Pines(SP): Sales are down 35% from 2017. This is on trend with sales across the mid valleys which, at this time, are down 28% from 2017. So far this year 11 units have sold in SP. The average sold price so far this year is \$638,836 with the lowest price unit selling for \$515,000 and the highest going for \$730,000. The wide spectrum in these price differences can be explained by the fact that SP has such a wide variety

of sizes, finishings, views, floor plans etc. If you were to list your property today, you would likely be on the market for a couple of months because the average days on market in SP are currently 66. Also, 2018 is shaping up to be another strong year for Kelowna real estate though things are trending towards a more balanced buyer/seller market as opposed to the red hot sellers markets of 2016 and 2017.
