Please Inform the Office Staff

The SPHM administrators require necessary information from residents for their records. In summary: if you **sell your home**, your assistance in providing the administration office with the address of the home you sold and, if possible, the name, address, telephone number, email address, and the possession date of the new owner. If you have **just moved to our community**, please advise the administrators of your arrival.

A reminder for residents of the following:

- Renters The office staff have just discovered that the rental information is not up-to-date and homeowners need to keep the office staff apprised of renters in their home. A form is required to be filled out regarding renters. It is available on the SPHM website a click on the menu tab "Legal Documents" to view and download.
- **RV Insurance** When RVs are in storage in the RV lots, we require a copy of that storage insurance. Homeowners are only providing us with copies of insurance for the period of time they have their RVs on the road.

 and this slows down the process in having alterations approved

community and volunteer on a committee including:


- Two people to take on the gym maintenance.

Did You Know?

With new residents arriving in our community there are a few areas that we would like to bring not only to their attention but also to remind long-time residents.

- 1) Weed Control We live in a beautifully landscaped connumity where the majority of residents take care of their gardens and rock areas around their home. Unfornunately not all do so. Our By-laws state:
- **D, 1),** a) The landscape contractor is responsible for weed control in common areas only. (Parks, Pathways, Parking Lots, Boulevard etc.) Homeowners are responsible for weeding in the Personal Use Area around their home.
- b) Homeowners are required to control weeds on their property; owners can hire private contractors of their choice to undertake their weeding.

So we are asking all residents when they are out in their gardens to take a moment and check for weeds that are just appearing and remove them. We also recognize that some residents may be physically unable to do so. Please contact the office to ask for their assitance.



On your walk throughout the community, you may just feel inclinded to pull that small weed just showing it's head around the tree bases along Sonoma Pines or in the rocks next to the sidewalks. Of course it is not required for residents to do so but I know some residents who do this often.

2) How to Deal with those PESKY Marmots There have been many requests by residents regarding how
